“INSTRUCTIONS”

- All the officers posted above shall perform their duties strictly within the specified area and shall not perform overlapping functions assigned to any other officer.
- In case any officer has actionable intelligence, the same shall be shared with. In charge Operations/Admin ASO and shall act as directed/planned by the Headquarters. No action whatsoever shall be taken at their own by any officer beyond the area of his responsibility
- Officers posted in legal cell shall ensure attendance in all the cases within the area of their allocated responsibility. They will completely record all the proceedings on the file, once they attend the case at respective forum and complete the note sheet side of the file and submit the same through SPO I/C Legal without fail.
- All the officers posted at C.P Guardian shall perform their duties in proper uniform and ensure that no unauthorized person is onboard.
- Officers proceeding on Intelligence/Patrolling duties shall maintain their diaries regularly.
- Officers posted at CP Machko, CP Super Highway and CP Ghaggar Phatak shall submit daily action report on the approved formats and no excuse in this regard will be accepted.
- All IPSs in field formations and Check posts will submit weekly progress report to SPS/ASO regularly.
- No officer/Sepoy/Jamadars will leave his place of posting without being relieved.
- Officers /Jamadar/Sepoy's at Mobile Squad Check Posts will wear proper uniform while performing duty.
- All In-charges will attend General Meeting being held on every Saturday at ASO Headquarters.
- The officers posted at Check Points will depute Sepoys in rotation for two hours to check the vehicles / buses being checked and will also mention this in the diary.
- Non-attendance of / Jamadars & Sepoys must be reported to I/C IPS In-Charge Administration immediately.
- Officers posted on Intelligence duties shall visit State Warehouse-III, Keamari, to check presence of Sepoy.
- Officer In-Charge State Warehouse-III shall maintain strict vigil and keep record Stock Register to avoid any pilferage.
- Allocated vehicle shall only be used for official duties.
- Duty officer shall record the movement of every vehicle in his diary with the time of leaving/return mentioning the name of driver and accompanying officer. Particulars of all persons in custody shall be maintained in a separate register. Custody shall properly be handed over/taken over with the charge of the armory.
- No arms and ammunition shall be issued to any officer without the explicit approval of the SPS/ASO.
- Officers are directed to Board the vessel in uniform, SPS to ensure strict compliance and report any deviation accordingly. SPS Gate Wharves to ensure the attendance of staff and monitor the day to day working of computer units installed at gates under his jurisdiction and submit report to concerned Assistant Collector immediately in case of malfunctioning if any.
- Psw (Vessel Agent Monitoring And Facilitation). Officers Posted in Relevant GDR / Boarding to obtain IDs from PSW
- Officers are directed to get their one-Customs/WeBOC internal user IDs immediately from office of Deputy Collector-MIS. Concerned SPS/IPS shall coordinate with MIS Section regarding issuance of IDs and shall certify in writing that all officers have got their respective IDs within 24 hours.
